Market Quality Engine: Spread and Depth

Problem

- Wide spreads increase trading costs, violate exchange requirements, and make markets unattractive.
- ☑ Insufficient liquidity within ±2% of price leads to penalties and sudden price swings.

Solution

- Automated spread control with dynamic adaptation to market conditions.
- Strategic order placement to maintain a two-sided liquidity buffer.

Chart Health Optimizer

Problem

Gaps, spikes, and "broken" candles repel institutional and algorithmic traders.

Solution

Real-time anomaly smoothing and correction on intraday timeframes (up to 15 minutes).

- ✓ Eliminates up to 95% of chart anomalies.
- ✓ Attracts algorithmic traders.
- Builds market trust.




Liquidity Depth

Liquidity available within your chosen % range from market price.




Balance History

Clear view of portfolio changes and performance over time.




Volume Intelligence




